



OFFICIAL RULES FOR “BIG GAME GIVEAWAY” SWEEPSTAKES. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

1. **ELIGIBILITY:** In order to be eligible to participate in the “BIG GAME GIVEAWAY” (“Sweepstakes”), each entrant must be 18 years of age or older as of the start date, and a legal resident of the United States. Proof of eligibility will be required. The Prizes are nontransferable. No cash redemptions or other prize substitutions allowed for all or any part of any Prize. Prizes may be issues in the form of a gift card or other type of credit voucher at solely Sponsor’s discretion, with store or brand of issuance varying by location of the Property where the winning entry was submitted.
